Program Highlights for October 2011

- I. Office of Veterans Affairs: The Tribal Veteran's Representative received 32 calls for services in October. He also met with 32 veterans in person and had 433 outreach contacts with other providers. T.V.R. met with Veterans in Stilwell, Jay, Grove, Muskogee, Colcord and Tahlequah. T.V.R. held Veterans Reception during Cherokee Holiday.
- 2. Bright Futures (Truancy Prevention): The Bright Futures program is serving seven youth from six families in the month of October. All seven youth have shown improvement in their school attendance and grades.
- 3. Child Care & Development: The Child Care data system crashed 8/17/10 and was not recoverable. Although the system crashed families continue to be served. Processes are all performed by hand until the new data system can be implemented. In October, the families of 421 children applied for child care services and there were 232 new calls for information.
- 4. ICW Child Protective Services (CPS): Three was one referral of child abuse on Indian Country in October. There were 79 reports of child abuse and neglect of Cherokee children on state land.
- 5. ICW Court Advocacy and Permanency (CAPS) Units: There are 1183 Cherokee children with assigned ICW workers. These children and cases are from the Tribal, State, and Out-Of-District Units. In October, ICW workers appeared in court 259 times in courts across the United States.
- 6. ICW for Guardianships and Private Adoptions: There are 223 children on the GPA caseload. Of these 133 are from within the 14 counties, 25 in Tribal Court and 65 out of district. There are 19 birth parents wishing to place their children for adoption. Four private adoptions finalized.
- 7. ICW Mayes County Prevention Program: The MCPP provided services to 87 children and 65 adults in October. Fifty-Two families received services.
- 8. John Ketcher Youth Shelter: Eighteen youth spent time at the John Ketcher Youth Shelter in October, 14 were new admissions and 4 carried over from September.
- **9. Juvenile first time offender program:** Six young people carried over from September. There were 6 sessions to a total of 7 participants. There were 3 successful completions. There were eight new referrals. Eleven young people are expected to complete in November. Two youth completed 12 community service hours.
- 10. Family Assistance (Food Distribution): There were 9,522individuals served this month.
- II. Family Assistance (Elderly Nutrition): There were 3,493 hot meals served at Elderly Nutrition Sites.
- 12. Family Assistance (LIHEAP): There were 40 households served for Winter/Summer Crisis.

- 13. Child Support Services: The child support distribution for September was \$199,270.00. There are a total of 2,800 child support cases. Michelle Locust worked on the coat voucher program.
- 14. Success Stories: The office of Child Support Services has been working towards expanding its outreach to citizens in the past year. We have bridged a partnership with two of the CN health facilities-Hastings Hospital and Three Rivers Clinic by attending monthly meetings to expecting parents about services child support can offer to Cherokee citizens such as paternity establishment through DNA testing and educating them about the Office. Child Support staff attends these meetings each month in an attempt to answer any questions expectant parents may have about child support services

b. Notable accomplishments

- 1. Program to date, 339 families unable to obtain a non-predatory mortgage on their own have completed self-sufficiency counseling and obtained a non-predatory mortgage.
- 2. YTD, Self Sufficiency staff members have worked with 17 families facing foreclosure. Staff have helped 1 family save their home from foreclosure (1 homeowners received a temporary workout repayment plan). 16 families are still in the process of trying to save their homes.

1. Commerce has requested funding to provide MAP to 255 families in FY12. Commerce has only operated the Mortgage Assistance Program for 2 ½ years, and two of those years have likely been skewed because of the tax incentives in FY10 and then the reduced number of buyers in the market during FY11. We believe that FY12 should put us back on track with Mortgage Assistance Program performance since its inception; program to date, on average 240 families utilize MAP annually.

d. Foreclosure information

- 1. Cumulative MAP foreclosure rate is 3.5%; this figure is based on the active foreclosure filings for MAP all MAP distributions (FY05 FY11).
- 2. RealtyTrac reports that Tulsa county had the top foreclosure rate in Oklahoma during the first half of 2011 with 1 in every 82 housing units receiving a foreclosure notice; Rogers county posted the third highest foreclosure rate with 1 in every 103 housing units receiving a foreclosure notice.
- 3. Oklahoma accounted for just under 1% of the nation's foreclosures in the first half of 2011.
- 4. Housing analysts predict the nationwide foreclosure crisis will continue for the next two to three years as a result of lenders slowing down their foreclosure process. Lenders are holding approximately 850,000 foreclosed homes on their books and another 1.1 million homes are in earlier stages of foreclosure. Experts estimate another three million homes will be foreclosed before the housing market stabilizes.
- 5. Mortgage delinquencies actually fell in Q2 2011 but Housing Analysts warn against getting too excited because they believe delinquency rates are improving as a result of the sudden tightened lending standards in 2008 after 10 years of frenzied mortgage lending. Those mortgages made after 2008 under the more stringent lending standards are performing much better than loans written during the early 2000s.
- 6. The federal government announced a new plan in October to help underwater homeowners refinance their existing mortgages at today's lower rates, and although it will help a hand full of homeowners, the scope of the program is still limited. The refinance program will allow home owners with mortgages owned or backed by Fannie Mae and Freddie Mac the ability to refinance even if they owe more than 125% of their home's value. Borrowers who have had more than 1

late payment in the previous 6 months or who have more than 1 late payment in the previous year will not qualify. Some closing costs will be waived and lenders' participation in the program is voluntary. The program should be available around December 1st.
