**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation is desirous of participation in the ICDBG grant program through submission of an application for Emergency Management in partnership with Head Start for Fiscal Year 2016;

**WHEREAS**, HUD has set out requirements for citizen participation as a prerequisite to application;


**WHEREAS**, the Cherokee Nation is continuously seeking and responding to citizen questions and comments through ongoing processes of the Tribe in order to better serve its citizenry;







**NARRATIVE:**

The Cherokee Nation Marshal Service will be applying for the 2016 ICDBG (Indian Community Development Block Grant) to install safe rooms in the Cherokee Nation owned Head Start facilities. The application requires citizen participation, in accordance with 24 CFR 1003. This requirement is to be certified in the form of a tribal resolution.
