CALL TO ORDER

Chair Jack Baker called the meeting to order at 10:25 a.m.

APPROVAL OF MINUTES

Councilor Julia Coates made a motion to approve the November 17th regular session and November 17th PAC Subcommittee minutes. Councilor Garvin seconded the motion. Motion carried.

REPORTS:

Financial Report/Treasurer Report - Callie Catcher

Callie Catcher reported they have issued a request for proposals on financing for the Vinita Clinic and those are due back today. They will be evaluating the proposals and hopefully start working on financing to get that clinic construction going.

Cherokee Nation Entertainment - David Stewart

David Stewart reported game revenues are holding from last year but the operating expenses are up, payroll is up due to giving employees a 3% merit raise. All projects are on schedule and on budget. Cultural Tourism is doing well and they have opened up the retail store for Cherokee Art at Hard Rock.

Cherokee Nation Businesses - David Stewart

David Stewart reported all companies are doing well and CNB continues to provide some governance to the subsidiaries in terms of looking at their operations to make sure best practice and procedures are in place. The combination of the boards is still in process and they are 60-90 days away. The Chief will be working on this issue therefore, it is essentially in his hands to push it forward. Councilor Glory-Jordan inquired if CNB provides bonding and a line of credit. David Stewart stated CNB does provide some bonding capability to all the different companies and also a credit line to CNI at their request. Councilor Glory-Jordan inquired as to what point the board will look at them not making money. David Stewart stated from a busines stand point the board of that company essentially has the responsibility for authorizing the note and they basically look at it to make sure that process is followed and there is some due diligence at CNI level. Councilor Frailey thanked Mr. Stewart for CNB's efforts on diversification. She also asked when they diversify and purchase a new company how do they develop and get the employees ready. David Stewart stated CNE has a leadership program where they go through and identify high potential employees who are part of that leadership program and essentially try to educate them about the process at CNE and the Tribe. Bob Schooly, CNE employee heads up the leadership program. Councilor Fishinghaw asked if Bob Schooly is Cherokee. David Stewart stated no he is not Cherokee. Councilor Cowan Watts stated she would like to understand the leadership program and the work Bob Schooly does. David Stewart offered a copy of the power point of the program.

Cherokee Nation Industries - Robert Drvostep

Robert Drvostep reported they are still in the process of closing for the month of November, therefore he has not submitted a written report but would entertain any questions Council may have. Councilor Fishinghawk asked if CNI had the contract on Facet. Mr. Drvostep stated yes. He reported the Bixby project is substantially complete and they will be meeting with the owner on Monday for a walk through of the facility. Councilor Buzzard asked if there would be a loss on the Bixby project. Mr. Drvostep stated yes but that Bryan Collins would be working to try and recoup the loss.

Career Services/Employment - Diane Kelley

Diane Kelley distributed an overview report of the Day Work Program in addition to her written report. She entertained any questions Council may have.

Commerce - Anna Knight

Anna Knight entertained any questions Council may have about her written report.

Historical Society - Carey Tilley

Cherokee Nation Education Corporation - Shelley Butler-Allen
