BE IT RESOLVED BY THE CHEROKEE NATION, that the Tribal Council hereby authorizes an application be submitted to the U.S. Department of Health and Human Services for FY 2012 funding for a Low Income Home Energy Assistance Program (LIHEAP), and that the Principal Chief, and/or his/her authorized delegate(s) shall be authorized to negotiate all contract(s) and any amendments thereto.
