WHEREAS, Fannie E. Robinson is duly qualified and should be appointed as a member of the Board of Directors of Cherokee Nation Waste Management, LLC, to fill this vacancy of Seat One (1) pursuant to the laws of the Cherokee Nation;

**BE IT RESOLVED BY THE CHEROKEE NATION,** that Fannie E. Robinson is hereby confirmed as a member of the Board of Directors of Cherokee Nation Waste Management, LLC, and its successors, for a term from February, 2013, until February, 2016
