WHEREAS, the Principal Chief, as representative of the Cherokee Nation, is authorized to select the members of the Board of Directors subject to a majority vote of the Council of the Cherokee Nation; and

WHEREAS, Ralph Keen, Jr. is duly qualified to fill this position as a member of the Board of Directors of Cherokee Nation Administrative Appeals Board.

BE IT RESOLVED BY THE CHEROKEE NATION, that Ralph Keen, Jr. is hereby confirmed as a Member of the Administrative Appeals Board for a term beginning October 2007 and expiring on October 2011, as authorized by Legislative Act 12-96 and 38-05.
