BE IT RESOLVED BY THE CHEROKEE NATION, that Dan Agent is hereby confirmed as a Board Member of the Editorial Board of the Cherokee Phoenix for a term effective January, 2008 through January, 2011 as authorized by Legislative Act 11-00, the Act of July 17, 2000.
