Mr. Garrett reported on the January financials. He announced gaming is picking up momentum, and the workforce is beginning to stabilize. He provided an update on federal contracting. The employees participated in a Junior Achievement Inspire Event earlier this month. He announced the upcoming exhibit at the John Ross Museum. We will have live racing for the 13th consecutive year at Will Rogers Downs. Councilor Crittenden requested an update on the Arkansas casino.

Career Services/Employment - Diane Kelley
