# A RESOLUTION CONFIRMING THE REAPPOINTMENT OF NATHAN BARNARD AS A DISTRICT JUDGE OF THE CHEROKEE NATION DISTRICT COURT

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people; and,

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and,

**WHEREAS**, the Cherokee Nation District Court was created and authorized by Title 20, Section 11-12, of the Cherokee Nation Code Annotated (CNCA); and,

**WHEREAS**, the Principal Chief is authorized to appoint District Judges of the District Court, subject to majority vote of the Council of the Cherokee Nation; and,

WHEREAS, Nathan Barnard is duly qualified to serve as District Court Judge for the Cherokee Nation.

**BE IT RESOLVED BY THE CHEROKEE NATION,** that the Council of the Cherokee Nation hereby confirm Nathan Barnard to the position of District Judge of the Cherokee Nation District Couty for a term of four (4) years, beginning April 2025 and ending April 31, 2029.
