LEGISLATIVE ACT 23-14

AN ACT AMENDING LEGISLATIVE ACT #21-13 AUTHORIZING THE COMPREHENSIVE OPERATING BUDGET FOR FISCAL YEAR 2014 - Mod. 12; AND DECLARING AN EMERGENCY

BE IT ENACTED BY THE CHEROKEE NATION:

SECTION 1. TITLE AND CODIFICATION

This legislative act shall be titled and codified as "An Act Amending Legislative Act #21-13 Authorizing the Comprehensive Operating Budget for FY 2014 – Mod. 12".

SECTION 2. PURPOSE

The purpose of this amendment is to authorize and approve the use of funds, subject to the availability of such funds, in accordance with Section 4, changing the amounts of certain cost centers approved in the "Comprehensive Budget Act for Fiscal Year 2014" or subsequent amendment. The cumulative total of the budget is increased by \$ 5,458,885 for a total budget authority of \$\\$623,870,657. The following items are identified as components of such change:

Grants Received & Authorized per LA-21-13 (detail attached) \$ 1,152,888 Modification Request (see Section 4 below) 4,305,997 Cumulative change in budget authority **5,458,885**

SECTION 3. LEGISLATIVE HISTORY

The provisions of compliance, policy of accountability, authorities and severability provided in Legislative Act #21-13 are applicable to this amendment.

SECTION 4. FUNDING AUTHORIZATIONS

The changes reflect increases to cost centers set forth in the program budget justifications incorporated herein. This modification request changes the total amount of the comprehensive budget authorization by an increase of \$\\$4,305,997\$ to wit:

- A. An increase in the **General Fund** budget authority of \$ 2,493,051.
- B. An increase in the **Motor Fuel Tax** budget authority of \$ 687,000.
- C. An increase in the **Indirect Cost Pool** budget authority of \$ 3,878.

- D. An increase in the **DOI General** budget authority of \$1,073,394.
- E. An increase in the **DOI Self Governance** budget authority of \$48,674.

SECTION 5. PROVISIONS AS CUMULATIVE

The provisions of this Act shall be cumulative to existing law.

SECTION 6. SEVERABILITY

The provisions of this Act are severable and if any part or provision hereof shall be held void the decision of the court so holding shall not affect or impair any of the remaining parts or provisions of this Act.

SECTION 7. EFFECTIVE DATE: EMERGENCY DECLARED

It being immediately necessary for the welfare of the Cherokee Nation, the Council hereby declares that an emergency exists, by reason whereof this Act shall take effect immediately upon its approval and signatures.

SECTION 8. SELF-HELP CONTRIBUTIONS

To the extent that this Act involves programs or services to citizens of the Nation or others, self-help contributions shall be required, unless specifically prohibited by the funding agency, or a waiver is granted due to physical or mental incapacity of the participant to contribute.

Per your request, I have reviewed the administration's budget modification request for this month's Executive & Finance Committee Meeting. Below is a summary of my review:

A. Grant Reporting:

B. MOD #12 Request - (11 budgets) Increase in budget authority - \$4,305,997

1. <u>Charitable Contributions – 1010042 – General Fund:</u> Modification requesting a decrease in expenditure authorization of \$11,513. This will fund the additional need request for the CN Rodeo in Land Development item 6.

- 2. <u>Sequoyah Activity Fund 1010169 General Fund:</u> New budget requesting expenditure authorization of \$90,000 to bring the SHS Activity Fund under the Cherokee Nation and its financial systems. Revenues are also budgeted at \$90,000 so this is a net zero budget.
- 3. <u>General Fund Operations 1010280 General Fund:</u> Modification requesting an increase in expenditure authorization of \$2,369,695. Funds are provided by a transfer in of \$2,400,000 from the Tribal Complex Roof Replacement budget in the Capital Mod #9 request. The \$2,369,695 will be transferred out to the following: MFT Higher Ed Scholarships \$687,000 (item 7.), SHS Education Administration \$1,258,935 (item 9.), and SHS Facilities Projects \$423,760 (item 10.)
- Cherokee Publications GF 1011070 General Fund: Modification requesting an increase in expenditure authorization of \$4,739 from additional donations received on CN Publications Subscriptions Donations in item 5.
- 5. <u>CN Publications Subscriptions Donations 1011071 General Fund:</u> Modification requesting an increase in expenditure authorization of \$8,617 from an increase in estimated donations. This \$8,617 will be transferred out to items 4 (55%) and 8 (45%).
- 6. <u>Land Development 1012350 General Fund:</u> Modification requesting an increase in expenditure authorization of \$31,513 for the CN Rodeo. The funds are provided by \$20,000 for sponsorships and \$11,513 (\$10,000 + IDC) from funding freed up in Charitable Contributions in item 1.
- 7. MFT Higher Ed Scholarships 1024001 Motor Fuel Tax: Modification requesting an increase in expenditure authorization of \$687,000 for scholarships due to a growth of 300 students. This will bring the total for this budget to \$11,203,500. Of the total, \$5,259,668 is from Motor Fuels Tax (MFT) and the balance of \$5,943,832 is provided from the General Fund.
- 8. <u>Cherokee Publications IDC 2041030 Indirect Cost Pool:</u> Modification requesting an increase in expenditure authorization of \$3,878 from additional donations received on CN Publications Subscriptions Donations in item 5.
- 9. <u>SHS Education Administration 3200000 DOI General:</u> Modification requesting an increase in expenditure authorization of \$258,220. The Grant Revenues are reduced by \$1,001,465, Contributions and Donations are increased by \$300, Other Income is increased by \$450, Operating Expenditures are increased by \$258,220 as already mentioned, and the balance is funded by a Transfer In of \$1,258,935 from General Fund Operations in item 3.
- 10. <u>SHS Facilities Projects 3201100 DOI General:</u> Modification requesting an increase in expenditure authorization of \$815,174. These funds are provided by a \$423,760 transfer in from General Fund Operations in item 3 and additional grant revenue of \$391,414. The total budget and project list attached is now \$2,743,897.
- 11. <u>Competitive Projects 3221900 DOI Self Governance:</u> Modification requesting an increase in expenditure authorization of \$48,674 from additional earmarked funding. \$22,574 is for Tar Creek and \$26,100 is for National Zinc. The new total for this budget is now \$164,674.

Summary:

After reviewing the submission of Mod #12 by administration, I find no technical issues surrounding these requests, nor do I have any concerns related to their respective carryover estimates. If I can provide any further information, please do not hesitate to contact me.
