A RESOLUTION CONFIRMING THE NOMINATION OF LORI SMILEY AS AN ADVISORY COMMITTEE MEMBER OF CHEROKEE NATIONAL TREASURES **PROGRAM**

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, Resolution Number 73-88 was enacted establishing the "Living National Treasures-Master Craftsman Series of the Lost Arts Program" on August 13, 1988, and amended to be named the Cherokee National Treasures Program in June 2008;

WHEREAS, all elected and appointed officers of the Nation are bound by oath to promote the culture, heritage and traditions of the Cherokee Nation (Cherokee Constitution, Article XIII Section 1);

WHEREAS, there shall be an Advisory Committee made up of five members who shall provide their recommendations for up to three (3) National Treasurers to the Principal Chief;

WHEREAS, the Advisory Committee Members shall be nominated by the Principal Chief and confirmed by the Tribal Council pursuant to Legislative Act 30-04;

WHEREAS, Lori Smiley is duly qualified and has been nominated to the advisory committee on National Treasure Award by the Principal Chief, for a term of one year.

BE IT RESOLVED BY THE CHEROKEE NATION, that Lori Smiley is hereby confirmed as as a Member of the Cherokee Nation National Treasures Program Advisory Committee and is hereby confirmed for a term of one year.
