LEGISLATIVE ACT 20-09

AN ACT AMENDING LEGISLATIVE ACT #19-08 AUTHORIZING THE COMPREHENSIVE BUDGET FOR FISCAL YEAR 2009 – Mod. 10; AND DECLARING AN EMERGENCY

BE IT ENACTED BY THE CHEROKEE NATION:

SECTION 1. TITLE AND CODIFICATION

This legislative act shall be titled and codified as “An Act Amending Legislative Act #19-08 Authorizing the Comprehensive Budget for Fiscal Year 2009 – Mod. 10”.

SECTION 2. PURPOSE

The purpose of this amendment is to authorize and approve the use of funds, subject to the availability of such funds, in accordance with Section 4, changing the amounts of certain cost centers approved in the “Comprehensive Budget Act for Fiscal Year 2009” or subsequent amendment. The cumulative total of the budget is increased by **\$13,985,015** for a total budget authority of **\$591,100,603**. The following items are identified as estimated General Fund sources in excess of appropriated uses to wit:

SECTION 3. LEGISLATIVE HISTORY

The provisions of compliance, policy of accountability, authorities and severability provided in Legislative Act #19-08 are applicable to this amendment.

SECTION 4. FUNDING AUTHORIZATIONS

The changes reflect increases to cost centers set forth in the program budget justifications incorporated herein. This amendment changes the total amount of the comprehensive budget authorization by a net increase of **\$13,985,015** to wit:

- A. An increase in the **General Fund** budget authority of **\$1,275,196** related to infrastructure costs at the Vinita Clinic site, Saline Courthouse, and funding supplements for the Clothing for Kids and Higher Education Scholarship programs.

- B. An increase in the **Motor Vehicle Tax Fund** budget authority of \$3,572,617 to authorize a transfer pursuant to the purchase and retirement of 2006 Series Health Care Bonds as well as authorize additional scholarship funds.
- C. A net decrease in the **Enterprise Fund** budget authority of <\$820,157> primarily related to a reduction in program income for the current year.
- D. An increase in the **DOI Self Governance Fund** budget authority of \$222,516 related to a pass-thru wind energy grant to CNE, increased other funding on the Indian Child Welfare program and a budget correction on the Housing Improvement Program.
- E. An increase in the **IHS Self Governance - Health Fund** budget authority of \$2,396,388 related to additional current and prior year Contract Health Service funding.
- F. An increase in the **IHS Self Governance – Environmental Health Fund** budget authority of \$149,941 related to additional program support funding.
- G. A net increase in the **NAHASDA Fund** budget authority of \$2,513,141 primarily to transfer Title VI loan funds for debt service, authorize 2009 IHP Mortgage Assistance funds as well as various reallocations within the 2008 IHP and Economic Stimulus funds.
- H. An increase in the **Capital Projects Fund** budget authority of \$1,429,756 related to closing out the Nowata and Sallisaw Clinic Construction budgets as well as authorizes the remaining expenditure on the Muskogee Clinic Construction budget.
- I. An increase in the **Debt Service Pool** budget authority of \$3,245,617 to purchase and retire the previously authorized bond buy-back and substitute the debt with an internal obligation to the Motor Fuels Tax Education Encumbrance Reserve.

SECTION 5. PROVISIONS AS CUMULATIVE

The provisions of this Act shall be cumulative to existing law.

SECTION 6. SEVERABILITY

The provisions of this Act are severable and if any part or provision hereof shall be held void the decision of the court so holding shall not affect or impair any of the remaining parts or provisions of this Act.

SECTION 7. EFFECTIVE DATE: EMERGENCY DECLARED

It being immediately necessary for the welfare of the Cherokee Nation, the Council hereby declares that an emergency exists, by reason whereof this Act shall take effect immediately upon its approval and signatures.

SECTION 8. SELF-HELP CONTRIBUTIONS

To the extent that this Act involves programs or services to citizens of the Nation or others, self-help contributions shall be required, unless specifically prohibited by the funding agency, or a waiver is granted due to physical or mental incapacity of the participant to contribute.





Per your request, I have reviewed the administration's budget modification request for this month's Executive & Finance Committee Meeting. Below is a summary of my review:

A. JUNE - GRANTS RECEIVED (REPORTING ONLY):

(1): Land Development: Requesting an increase in spending authority of **\$111,196** for supplies and contract services to stabilize the channel walls at the holding pond at the Saline Courthouse Spring House.

(2): Vinita Clinic Utilities ****New Initiative****: Requesting new spending authority of **\$639,000** for infrastructure costs associated with getting utilities to the new site of the Vinita Clinic.

Motor Fuels Tax Fund: (Increase - \$3,237,617)

(3): MFT Scholarship Encumbrance: This budget merely a follow up to the 2009 Health Care Bond Buy-Back Legislation passed earlier in the fiscal year. This budget allows for the technical entry of fund transfers from the MFT fund to the Debt Service Fund for the purchase and retirement of the bonds and accrued interest in the amount of **\$3,237,617**. Please keep in mind the debt is not retired from the Health Group, merely substituted with an internal promissory note to the MFT Encumbrance Reserve, instead of a third party bond holder.

Enterprise Fund: (Net Decrease - <\$820,157>)

(4): Title VI Loan Fund: This budget is reducing Interest Income projection and the associated loan interest expense resulting in a budget reduction of **<\$834,805>**. It also is reflecting a transfer-in of \$3.2 million of Program Income from the Title VI Subsidy budget (see item #15) below. This transfer is to be used for a principal reduction payment on the outstanding Title VI Loan balance. The long-term portion of the loan balance as of May 31st is approximately \$22.4 million before this additional principal payment.

(5 & 6): Tribal Loan Fund/Emergency Loan Fund: These budgets close out the Emergency Loan Fund and transfer the residual balance of that fund into the Tribal Loan Fund. The close out transfer has a net effect on the budget in the amount of **\$14,648**.

DOI Self Governance: (Increase – \$222,516)

(7): Energy and Mineral Development: Requesting an increase of **\$68,000** in budgetary authority to provide for the transfer of Year-2 funding of the Wind Project to CNE in the form of a sub-grant.

(8): Housing Improvement Program (HIP): Requesting a budget modification of **\$45,516** related to correcting the budget to reflect the IDC funding on top of the previously budgeted grant funding, for a new program total budget of \$380,084.

(9): Indian Child Welfare: Requesting a **\$109,000** budget increase due to “Other Income” on the program related to IVE Claims thus far this year being significantly in excess of previously anticipated levels.

IHS Self Governance – Health Fund: (Increase - \$2,396,388)

(10): Contract Health Services: Requesting an increase in spending authority of **\$2,396,388** of program funds. The current year additional funding award is \$1,632,315 and funds awarded last fiscal year (8/14/08); also are part of this increased spending request, in the amount of \$764,073.

IHS Self Governance – Environmental Health Fund: (Increase - \$149,941)

(11): Environmental Health Svc - Administration: Requesting an increase in spending authority of **\$149,941** of additional program support funds from Indian Health Service not previously in the current year budget.

NAHASDA Fund: (Net Increase – \$2,513,141)

Capital Projects Fund: (Increase - \$1,429,756)

(22): Nowata Clinic: Requesting to receive in a transfer from the Muskogee Construction Budget to close out the Construction costs at the Nowata Clinic in the amount of **\$122,764**.

(23): Muskogee Clinic: Requesting carryover funds to cover supplies and capital expenditures and close out the Nowata, Sallisaw and Muskogee Construction projects. A total use of funds equals **\$1,146,874**.

(24): Sallisaw Admin Office: Requesting authority to transfer residual fund balance to the Muskogee Construction budget in the amount of **\$160,118**.

Debt Service Pool: (Increase - \$3,245,617)

(25): Health Construction Debt Service: This budget request follows up on the actual legislative act that authorized the MFT Education Trust to purchase the bonds from the third party bond holders. This budget authorization amount is \$3,245,617 which includes the bonds, accrued interest and a nominal bank service charge.

C. COMMUNITY ASSISTANCE, LAW ENFORCEMENT & CEMETERIES FUNDS:

The attached lists of projects have been approved, or are being requested to be approved in this Executive/Finance Committee. These projects have already been appropriated; therefore, there is no need to appropriate the funds again. This list is for informational purposes and is included within this mod package review for inclusion purposes.

Summary:

After reviewing the submission of Mod-10 by administration, I find no technical issues surrounding these requests, nor do I have any concerns related to their respective carryover estimates.
