WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Free and Independent Press for the Cherokee Nation, Editorial Board was created and authorized by Legislative Act 16-09;

WHEREAS, Ceciley Thomason Murphy is nominated by the Principal Chief to serve a sixyear term as an Editorial Board Member of the Cherokee Phoenix, as authorized by Legislative Act 16-09;

WHEREAS, Ceciley Thomason Murphy is duly qualified to fill this position pursuant to the laws of the Cherokee Nation;

**BE IT RESOLVED BY THE CHEROKEE NATION,** that Ceciley Thomason Murphy is hereby confirmed as a Board Member of the Cherokee Phoenix from October 2023 to October 2029 as authorized by Legislative Act 16-09.
