# LEGISLATIVE ACT <u>09-09</u>

# AN ACT AMENDING LEGISLATIVE ACT #19-08 AUTHORIZING THE COMPREHENSIVE BUDGET FOR FISCAL YEAR 2009 – Mod. 5b "Economic Stimulus Package"; AND DECLARING AN EMERGENCY

#### BE IT ENACTED BY THE CHEROKEE NATION:

# **SECTION 1. TITLE AND CODIFICATION**

This legislative act shall be titled and codified as "An Act Amending Legislative Act #19-08 Authorizing the Comprehensive Budget for Fiscal Year 2009 – Mod. 5b Economic Stimulus Package".

# **SECTION 2. PURPOSE**

The purpose of this amendment is to authorize and approve the use of funds, subject to the availability of such funds, in accordance with Section 4, changing the amounts of certain cost centers approved in the "Comprehensive Budget Act for Fiscal Year 2009" or subsequent amendment. The cumulative total of the budget is increased by \$42,533,659 for a total budget authority of \$548,218,739. The following items are identified as estimated General Fund sources in excess of appropriated uses to wit:

#### **SECTION 3. LEGISLATIVE HISTORY**

The provisions of compliance, policy of accountability, authorities and severability provided in Legislative Act #19-08 are applicable to this amendment.

# **SECTION 4. FUNDING AUTHORIZATIONS**

The changes reflect increases to cost centers set forth in the program budget justifications incorporated herein. This amendment changes the total amount of the comprehensive budget authorization by a net increase of \$42,533,659 to wit:

A. An increase in the **D.O.I.** – **Self Governance Roads** budget authority of \$12,171,497 related to potential future economic stimulus funding from the federal government.

- B. An increase in the **D.O.I. Self Governance** budget authority of <u>\$846,662</u> related to potential future economic stimulus funding from the federal government.
- C. An increase in the **D.O.I. PL** 102-477 budget authority of \$900,000 related to potential future economic stimulus funding from the federal government.
- D. An increase in the **I.H.S. Self Governance Health** budget authority of \$6,715,500 related to potential future economic stimulus funding from the federal government.
- E. An increase in the **I.H.S. Self Governance TEH** budget authority of \$10,000,000 related to potential future economic stimulus funding from the federal government.
- F. An increase in the **NAHASDA** budget authority of \$11,900,000 related to potential future economic stimulus funding from the federal government.

#### **SECTION 5. PROVISIONS AS CUMULATIVE**

The provisions of this Act shall be cumulative to existing law.

# **SECTION 6. SEVERABILITY**

The provisions of this Act are severable and if any part or provision hereof shall be held void the decision of the court so holding shall not affect or impair any of the remaining parts or provisions of this Act.

# SECTION 7. EFFECTIVE DATE: EMERGENCY DECLARED

It being immediately necessary for the welfare of the Cherokee Nation, the Council hereby declares that an emergency exists, by reason whereof this Act shall take effect immediately upon its approval and signatures.

## **SECTION 8. SELF-HELP CONTRIBUTIONS**

To the extent that this Act involves programs or services to citizens of the Nation or others, self-help contributions shall be required, unless specifically prohibited by the funding agency, or a waiver is granted due to physical or mental incapacity of the participant to contribute.
