WHEREAS, the Principal Chief is authorized to select members of the Board of Directors subject to majority vote of the Council of the Cherokee Nation;

WHEREAS, Shelley Butler-Allen is duly qualified to fill this board position vacancy pursuant to the bylaws of the Cherokee Nation Education Corporation.

BE IT RESOLVED BY THE CHEROKEE NATION, that Shelley Butler-Allen is hereby confirmed as a Board Member of the Cherokee Nation Education Corporation Board of Directors for the term of four (4) years from December 31, 2008 until December 31, 2012.
