BE IT RESOLVED BY THE CHEROKEE NATION, that Jim Ketcher is hereby confirmed as a Board Member of Cherokee Nation Community Association Corporation for the term of (2) years from March 2008 until March 2010, as authorized by the Bylaws of Cherokee Nation Community Association Corporation.
