WHEREAS, the Principal Chief is authorized to select members of the Board of Directors subject to majority vote of the Council of the Cherokee Nation;

WHEREAS, Marilyn Watt is duly qualified to fill this board position vacancy pursuant to the bylaws of the Cherokee Nation Education Corporation.

BE IT RESOLVED BY THE CHEROKEE NATION, that Marilyn Watt is hereby confirmed as a Board Member of the Cherokee Nation Education Corporation Board of Directors for the term of four (4) years from December 31, 2008 until December 31, 2012.
