A RESOLUTION APPROVING A CHANGE IN GRADE SPAN TO INCLUDE KINDERGARTEN AT THE GREASY IMMERSION CHARTER SCHOOL

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people; and

WHEREAS, the Cherokee Nation is a federally recognized Indian tribe that is eligible to sponsor a charter school pursuant to the Oklahoma Charter Schools Act, 70 O.S. § 3-132(7); and

WHEREAS, in Resolution 52-11, the Council of the Cherokee Nation approved the creation of the Tsunadeloquasdi Cherokee Immersion School, a tribally operated charter school located with the Cherokee Nation Reservation; and

WHEREAS, the Tsunadeloquasdi Cherokee Immersion School operates a site located in Greasy, Oklahoma called the Greasy Immersion Charter School; and

WHEREAS, the Tsunadeloquasdi Cherokee Immersion School wishes to conduct a change in grade span to include kindergarten at the Greasy Immersion Charter School.

BE IT RESOLVED BY THE CHEROKEE NATION, that the Council of the Cherokee Nation hereby approves a change in grade span to include kindergarten at the Greasy Immersion Charter School.
