RESOLUTION NO. 103-12

COUNCIL OF THE CHEROKEE NATION

A RESOLUTION CONFIRMING THE NOMINATION OF ANGELA JONES AS A JUSTICE OF THE CHEROKEE NATION SUPREME COURT

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, Justices of the Supreme Court are authorized in Article VIII Section 1 of the Constitution of the Cherokee Nation;

WHEREAS, according to Article VIII Section 2 of the Constitution, the Justices shall be appointed by the Principal Chief and confirmed by the Council of the Cherokee Nation;

WHEREAS, the terms of office for the Justice of Seat two (2) of the Supreme Court expires December 31, 2012;


WHEREAS, the Principal Chief has appointed Angela Jones as a Justice of the Supreme Court of the Cherokee Nation, Seat 2, to fulfill the duties of Justice as articulated in Article VIII of the Constitution;

WHEREAS, Angela Jones is duly qualified to fill this position.


BE IT RESOLVED BY THE CHEROKEE NATION, that Angela Jones is hereby confirmed as a Justice of the Supreme Court of the Cherokee Nation, Seat 2, to fulfill the duties of Justice as specified in Article VIII of the Constitution of the Cherokee Nation for a term beginning January 1, 2013 and ending December 31, 2022.

CERTIFICATION

The foregoing resolution was adopted by the Council of the Cherokee Nation at a duly called meeting on the 10th day of December, 2012, having 17 members present, constituting a quorum, by the vote of 16 yeas; 1 nays; 0 abstaining.

NARRATIVE:

The Supreme Court was created and authorized by Article VIII, Section 1 of the Cherokee Nation Constitution;

The Principal Chief is authorized to select the justices subject to majority vote of the Council of the Cherokee Nation;

The term of Justice of the Supreme Court of the Cherokee Nation, Seat Two (2) expires on December 31, 2012; and

Angela Jones is duly qualified to fill this vacancy.
