WHEREAS, the Principal Chief is authorized to select the members of the Board of Directors and Honorary members subject to majority vote of the Council of the Cherokee Nation; and

WHEREAS, Wilma Mankiller is duly qualified to fill this honorary position pursuant to the Bylaws of the Cherokee Nation Education Corporation.

**BE IT RESOLVED BY THE CHEROKEE NATION,** that Wilma Mankiller is hereby confirmed as an Honorary Board Member of Cherokee Nation Education Corporation for the term April 2009 through April 2013, as authorized by the Bylaws of Cherokee Nation Education Corporation.
