**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Marshal Service has the following equipment in its inventory that has been deemed surplus:

**WHEREAS**, the Cherokee Nation Marshal Service desires to donate this equipment in "as- is" condition.






