WHEREAS, a vacancy exist on the Board of Directors and Lorilee Smiley has been selected to be nominated by the Principal Chief;

WHEREAS, Lorilee Smiley is duly qualified to fill this vacancy pursuant to the laws of the Cherokee Nation.

BE IT RESOLVED BY THE CHEROKEE NATION, that Lorilee Smiley is hereby confirmed as a Board Member of the Cherokee Nation Economic Development Trust Authority Board of Directors for the term of one (1) year from July 2008 until July 2009.
