WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation Sequoyah High School Board of Education was established by Cherokee Nation Resolution No. 72-86;

WHEREAS, the Principal Chief is authorized to appoint Office #4 seat on the Board, subject to majority vote of the Council of the Cherokee Nation;

WHEREAS, the term of office of a Board Member expired October 2010;

WHEREAS, Amon Baker is duly qualified to fill this vacancy.

BE IT RESOLVED BY THE CHEROKEE NATION, that Amon Baker is hereby confirmed as a Board Member of the Cherokee Nation Sequoyah High School Board for the term of (5) five years from October 2010 until October 2015.
