WHEREAS, Cherokee Nation Businesses, LLC is a tribal Limited Liability Company created and authorized under the Cherokee Nation Limited Liability Company Act;

WHEREAS, the Principal Chief, as representative of the Cherokee Nation, is authorized to select the members of the Board of Directors subject to majority vote of the Council of the Cherokee Nation;

WHEREAS, Bob Berry is duly qualified and should be reappointed to as a member of the Board of Directors of Cherokee Nation Businesses, LLC, and its successors, for a term beginning November 11, 2014 and expiring November 30, 2017.

BE IT RESOLVED, that Bob Berry, is hereby confirmed as a member of the Board of Directors of Cherokee Nation Businesses, LLC and its successors, filling Seat 4 (four) to begin November 11, 2014 and expiring November 30, 2017.
