Executive Order No. 13-11-CS

1. **AUTHORITY:** The Constitution and laws of the Cherokee Nation.
2. **POLICY:** The executive power to conduct the business of the Nation is authorized by law in accordance with the terms of the Constitution. The Principal Chief has the fundamental responsibility to cause the laws of the Nation to be faithfully executed and to conduct in person and in such manner as shall be prescribed by law, all communications and business of the Cherokee Nation. (Cherokee Constitution, Article VII Section 9).
3. **PURPOSE:** The purpose of this order is to set out policy related to the execution of Resolution 92-10, "A Resolution Authorizing the Submission of a Grant Application to the Department of Housing and Urban Development (HUD) for an Indian Community Development Block Grant (ICDBG) Application for the Cherokee Cultural Arts Center and a Food Distribution Site in Collinsville." It is intended by this order to correct any unintentional oversight by not including the aforementioned phrase in the adopted resolution.
4. **ORDER:** It is hereby ordered:

Resolution 92-10, passed October 11, 2010 included discussion but did not include in the tribal resolution language that said, "the Cherokee Nation has met the citizen participation requirement of 24 CFR 1003.604(a) and made any necessary modifications to the application." This Executive Order should be included in the Legislative history and the Speaker of the Council is requested to do so as well as to formally notify the Council of the Cherokee Nation.
5. **EFFECTIVE DATE:** This order is effective immediately.

Cherokee Nation has met the citizen participation requirement of 24 CFR 1003.604(a) and considered any necessary modifications to the application.

As evidenced by the Executive Order 13-11-CS, the Constitution and laws of the Cherokee Nation provide the Principal Chief with this authority. Please accept the attached order signed by me to be placed in the legislative record supplementing the resolution regarding the Cherokee Nation's FY2010 ICDBG grant submission.
