CALL TO ORDER

Chair Glory-Jordan called the meeting to order at 2:03 p.m.

INVOCATION

Councilor Walkingstick gave the invocation.

APPROVAL OF MINUTES

Councilor Garvin moved to approve the October 10th regular session minutes. Councilor Cowan Watts seconded the motion. The motion carried.

REPORTS:

1. Human Services Department - Marsha Lamb

Ms. Lamb provided a handout showing a breakdown by county for the number of households served with LIHEAP last year with a total of 1,781 households served. Councilor Garvin requested a status update on the LIHEAP blankets. Ms. Lamb gave an update on the Veterans center. Chair Glory-Jordan requested an update next month on the funding situation for LIHEAP. Ms. Lamb announced the Nowata nutrition site is scheduled to open in January, the Collinsville food distribution center is scheduled for summer and the Stilwell Child Development center is scheduled for completion in approximately 18 months.

2. Community Services - David Southerland

Mr. Southerland reported he submitted a recommendation which was approved by Chief Baker for the 15 homes in Redbird Smith Addition to be mutual help homes based on income. The homes will be appraised and used as the purchase price which would only come into play if the family chooses to sell the home. They currently have twenty applications for these fifteen homes. All \$75,000 of the Adult Grant Funds has been obligated. Councilor Anglen inquired if there are any plans for the 10 acres in Collinsville. Mr. Southerland stated he has been requested by Chief Baker to review all currently owned land as they ramp up to build houses. Councilor Hoskin Jr. requested a breakdown for the Adult Grant showing where those who were approved live and the number of applications denied due to the lack of funds. He also requested feedback on how the program could be improved. He inquired about the status of the lots in Nowata. Mr. Southerland stated two ladies have applied for self-help homes and may use those lots. Councilor Thornton commented two schools in his district need homes built to help the school districts.

3. Roads & Transportation - Michael Lynn

Mr. Southerland announced there is a pre-construction meeting for the Barber Road project at the Dry Creek Community building on November 29th at 6:00 p.m. The Honey Hill project was finalized on November 1st and the final inspection for the Nicutt North project was held on the 11th of November. He offered to answer questions from the roads report provided.

Mr. Southerland gave the public disclosures for the month. The next board meeting is scheduled for noon tomorrow. He apologized for the conflict of timing with the committee meetings tomorrow. The December meeting is scheduled for the 20th at noon.

Mr. Southerland provided an update following recently held meetings. He stated if the \$20ml rule goes into effect we will be okay.

7. Commerce Housing Report - Anna Knight

Ms. Knight reported the couponing workshop is the most popular at this time due to the economy. She offered to answer questions from the report provided.
