**A RESOLUTION AUTHORIZING CHEROKEE NATION
WAREHOUSE TO DONATE SURPLUS ITEMS TO
BOWLIN SPRINGS COMMUNITY CENTER**

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;


WHEREAS, the Cherokee Nation Warehouse desires to donate these items in "as- is" condition.






