### A RESOLUTION CONFIRMING THE RENOMINATION OF STEVEN M. WILSON AS A COMMISSIONER OF THE CHEROKEE NATION TAX COMMISSION

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation Tax Commission Board of Commissioners was created and authorized by Title 68 §11 of the Cherokee Nation Code Annotated;

**WHEREAS**, the term of office for Steven M. Wilson's term as Commissioner has ended;


**WHEREAS**, Steven M. Wilson is duly qualified to fill this position and should be reappointed, pursuant to the laws of the Cherokee Nation.



### CERTIFICATION


