CALL TO ORDER

Chair Snell called the meeting to order at 4:30 p.m.

## REPORTS:

1. Management Resources - Bruce Davis

Mr. Davis offered to answer questions from the report provided. Councilor Byrd requested an update on the new tag office in Tahlequah. Councilor Cowan Watts requested an update on the hay and also the status of the buffalo. Councilor Taylor asked about the progress on the new Jack Brown Center. Councilor Glory Jordan inquired as to how many buffalo and where would they be placed. Councilor Garvin inquired about the plans for the old Council House. Councilor Buzzard gave an update on the garden project in Jay and requested additional research in the green houses for fruits and vegetables as well as cattle. Mr. Gulager gave an update on the hay, cattle, buffalo and gardens.

#### 2. Real Estate Services - Ginger Brown

Ms. Brown offered to answer questions from the report provided. Councilor Cowan Watts inquired if we are still trying to pursue the Claremore Federal Building. She requested clarification on the tribal lease process and hunting. Councilor Garvin inquired about the Bundy issue in Utah. Councilor Buzzard inquired about the ownership of the Oak Hill Community building in Delaware County. Councilor Byrd inquired if there is any acreage at the Oak Hill Community building. Councilor Cowan Watts inquired about the Natchez Nation seeking land into trust. Councilor Lay inquired about the status of the trust application for the casino and community building in South Coffeyville and requested clarification as to which one the State had issues with the application.

3. Environmental Programs - Tom Elkins

Mr. Elkins reported the Annual Environmental Festival was held recently with over 300 in attendance. He reported Bobby Short one of his Directors is now with CNB.

4. Veteran's Building Status Update - Bruce Davis
