BE IT RESOLVED BY THE CHEROKEE NATION, that Linda O'Leary is hereby confirmed as a member of the Cherokee Nation Gaming Commission, serving a term of (3) three years from the date confirmed by the Council of the Cherokee Nation through May 2027.
