## APPROVAL OF MINUTES

Councilor Anglen moved to approve the December 13th regular session minutes. Councilor BIII John Baker seconded the motion. Motion carried.

## REPORTS:

Management Resources - Angela Drewes

Ms. Drewes offered to answer questions from her written report and announced she had some updates on the questions posed to her prior to this meeting. Councilor Cowan Watts gave appreciation for all of the hard work organizing the Christmas parades. Councilor Glory-Jordan inquired about the bid on the Kirk property and voiced concern for the large number of horses on the property and over grazing. Ms. Drewes stated she would speak to Butch Garner about the property.

## 2. Real Estate Services - Linda Donelson

Ms. Donelson offered to answer questions from her report. Councilor Buzzard inquired which IHS facility we are considering acquiring. Ms. Donelson stated the North Street property which used to be part of the old Hastings hospital, the Hastings hospital facility, the Redbird Smith facility and the buildings at Mankiller clinic. Councilor Glory-Jordan gave appreciation for the bid reports recently received. Ms. Donelson announced they will begin the next cycle process in January of 2012. Councilor Glory-Jordan requested a copy of a lease agreement just to review the terms.

## 3. Environmental Programs - Tom Elkins

Mr. Elkins announced they will be only putting in one compressed natural gas facility instead of two due to increasing costs. He stated he did some research on earthquakes being associated with salt water injection wells and discovered they do occur but are usually minor with minimal damage.
