WHEREAS, the Cherokee Nation, since time immemorial, has exercised the sovereign right of self-government on behalf of the Cherokee people.

WHEREAS the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government-to-government relationship with the United States of America.

WHEREAS, the Cherokee Nation Warehouse has the following items in its inventory that have been deemed surplus:

The Cherokee Nation Warehouse desires to donate these items in "as-is" condition.

WHEREAS the B The Light Mission Foundation operates on limited funds within the Cherokee Nation's jurisdictional boundaries, donating said items would benefit them greatly.






