WHEREAS, the Cherokee Nation Warehouse has the following items in its inventory that have been deemed surplus:

The Cherokee Nation Warehouse desires to donate these items in "as-is" condition.

WHEREAS the B The Light Mission Foundation operates on limited funds within the Cherokee Nation's jurisdictional boundaries, donating said items would benefit them greatly.

BE IT RESOLVED BY THE CHEROKEE NATION that the Tribal Council authorizes Cherokee Nation Warehouse to donate these surplus items to B The Light Mission Foundation as set out above.
