WHEREAS, David Ballew is duly qualified and should be appointed as a member of the Board of Directors of Cherokee Nation Industries, LLC, and its successors, for a term that expires September 30, 2011, and pursuant to the attached Memorandum of Action of the Principal Chief of the Cherokee Nation.

**BE IT RESOLVED BY THE CHEROKEE NATION**, that David Ballew is hereby confirmed as a member of the Board of Directors of Cherokee Nation Industries, LLC, and its successors, for a term that expires September 30, 2011.
