STATE OF THE NATION
Bill John Baker
Principal Chief

With the upcoming holidays Principal Chief Bill John Baker focused his remarks on the programs that work to give a hand up to our brothers and sisters. Over the last six weeks our Behavioral Health Service team has secured seven grants. Our Education Department recently announced that the number of students receiving college scholarships is up by twenty percent. Our Career Services Group picked up two awards from the State of Oklahoma at the Economic Development Summit the first stemmed from a partnership with the State of Oklahoma as a Work Force program and Northeastern Oklahoma's Regional Association. The second award was presented for the tribes Work Force Development Work Ready Communities program. The Talking Leaves Job Corp Culinary Arts program placed 2nd in the Iron

Chef contest in Little Rock. Our Commerce Group has recently received a \$725,000 Community Development Assistance award from the U.S. Department of the Treasury. He commented these departments are truly helping us take the first steps of moving the Cherokee Nation from good to great. He requested remembrance of our service men and women over the holidays. Deputy Chief Joe Crittenden honored veterans Michael Greer and Benny Ross.

Monthly Reports:

Housing Authority - David Southerland

Mr. Southerland reported the November board meeting is scheduled for tomorrow at noon. They have a light agenda with the only item being the discussion of the development of housing. They have been monitoring the Indian Housing Block Grant housing bills currently in the Senate and the House.

Cherokee Nation Business, Inc - David Stewart

Mr. Stewart announced the financial result continue to be strong. They expect to close the year very close to budget with all companies in good health. The budget for 2012 has been completed with the total revenue exceeding \$700ml and more than 5,000 employees by years end. He reported the Community Impact Team consisting of 425 employees for the year of 2011 exceeded more than 5,000 volunteer hours, raised \$25,000 for the American Diabetes Association, \$12,000 for Big Brother and Sisters, more than 617 pints in blood donations. The ground breaking was held for the new hotel tower at Hard Rock and the John Ross Museum was opened. The Cherokee Services Group was named number one by Tulsa's Fast Forty.

3. 11-117 AN ACT ESTABLISHING PROCEDURES FOR APPLICATIONS FOR PLACING LAND INTO TRUST BY FOREIGN NATIVE AMERICAN TRIBES WITHIN THE JURISDICTION OF THE CHEROKEE NATION

Councilor Keener moved to approve. Councilor Cowan Watts seconded the motion. Councilor Coates offered a friendly amendment to adopt the alternate act provided today. This act is substantially the same with some clarifying language. The friendly amendment was accepted. Councilor Glory-Jordan requested Mr. Hembree give an explanation of the changes provided today. After several questions were raised Councilor Glory-Jordan moved to table back to committee. Councilor Hoskin Jr. seconded the motion.

The motion to table back to committee failed with the following roll call vote:

Councilor Hoskin Jr. offered a friendly amendment in Section 5C to add the word "actual" after the word assuming. Councilor Coates inquired as to the process for notification to the tribe. Attorney General Hammons gave an example of notification just received. Councilor Coates accepted the friendly amendment so long as the Council is included in the notification. Councilor Hoskin Jr. voiced concern for the willful neglect of duty not being outlined and no guidelines being provided. Upon reconsideration Councilor Coates withdrew her acceptance of the friendly amendment. Several Council members voiced concerns. Councilor Hoskin Jr. made a motion to add the word "actual" between assuming and notice in Section 5C. Councilor Fishinghawk seconded the motion.

Councilor Fishinghawk moved to approve. Councilor Hoskin Jr. seconded the motion. Councilor Cowan Watts offered a friendly amendment to add "for profit" in front of corporations in 18. The friendly amendment was accepted. Councilor Keener offered a friendly amendment to 18 to add language provided and read into the record. The friendly amendment was not accepted. Councilor Keener made a motion to amend to include the language just read. Councilor Cowan Watts seconded the motion. Councilor Thornton requested to be added as a sponsor.

After discussion was held the motion to amend failed with the following roll call vote:

Councilor Keener made a motion to amend to include language for a one-time dividend of \$35 million. He read the proposed language into the record. Councilor Cowan Watts seconded the motion. Councilor Hoskin commented this is an interesting discussion but this isn't the proper vehicle. He moved to table the idea to committee for additional discussion. Mr. Hembree stated it isn't appropriate to table an amendment that you would have to table the entire piece of legislation. Councilor Hoskin Jr. stated this amendment isn't Germaine and should be struck to be brought up on a different day in committee. Speaker Frailey agreed it isn't a Germaine discussion to this topic.
