WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, Cherokee Nation Businesses, Inc. is a Cherokee Nation Tribal Corporation created and authorized by the Cherokee Nation Tribal Corporation Act;


WHEREAS, the Principal Chief is authorized to select the members of the Board of Directors subject to a majority vote of the Council of the Cherokee Nation;

WHEREAS, David Ballew is duly qualified and should be appointed as a member of the Board of Directors of Cherokee Nation Businesses, Inc. for a term that expires September 30, 2008 and pursuant to the attached Memorandum of Action of the Shareholders of the Cherokee Nation Businesses, Inc.


