**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people; and

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America; and


**WHEREAS**, The Principal Chief, as a representative of the Cherokee Nation is authorized to select members of the Cherokee Nation Gaming Commission, subject to the majority vote of the Council of the Cherokee Nation; and,

**WHEREAS**, Dwight Birdwell is duly qualified and should be a member of the Cherokee Nation Gaming Commission and its successors.



### **CERTIFICATION**




