**A RESOLUTION ADOPTING STANDARDS FOR  
HOUSING REHABILITATION**

**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

**WHEREAS**, the Cherokee Nation has used Section 8 standards consistently for housing rehabilitation;


**WHEREAS**, Section 8 standards are consistent with safe, healthy living conditions;

**WHEREAS**, HUD requires formal adoption of standards as a threshold for application for ICDBG;


**BE IT RESOLVED BY THE CHEROKEE NATION**, that the Tribal Council hereby formally adopts Section 8 standards as the standards that will be used for Housing Rehabilitation services provided by the Cherokee Nation.


