CALL TO ORDER

Chair Fishinghawk called the meeting to order at 4:11 p.m.

APPROVAL OF MINUTES

REPORTS:

Financial Report/Treasurer Report - Lacey Horn

Ms. Horn offered to answer questions from the report provided. Councilor Cowan Watts inquired about the possibility of a \$5ml dividend coming from CNB.

Cherokee Nation Businesses - Shawn Slaton

Mr. Slaton presented financials for the month of June. The expansion at Ramona was opened on Tuesday with a record day. The grand opening for Ramona will be held on September 17th. They are still looking to open casino 3 at Catoosa in mid-September with the hotel portion opening in the later part of November or first of

December. Ft. Gibson is also scheduled to open in the later part of November. Their budget will be presented to the board for approval by the end of the month for final approval in September. He offered to answer questions from the reports provided. Councilor Cowan Watts requested opening dates be resent to the Council. She inquired about the major personnel changes recently taken place.

AN ACT AMENDING LEGISLATIVE ACT #20-11 AUTHORIZING THE COMPREHENSIVE BUDGET FOR FISCAL YEAR 2012 OPERATING - MOD 12; AND DECLARING AN EMERGENCY
