A RESOLUTION AUTHORIZING THE CHEROKEE NATION ENVIRONMENTAL PROGRAMS GROUP TO SUBMIT A FORMAL APPLICATION TO THE U.S. NATIONAL PARK SERVICE FOR A HISTORIC PRESERVATION GRANT FOR THE SALINE COURTHOUSE

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people,

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government-to-government relationship with the United States of America;

WHEREAS, the Cherokee Nation operates the Office of Environmental Programs;

WHEREAS, the National Parks Service has funds available to assist Indian tribes in operating preservation projects.

BE IT RESOLVED BY THE CHEROKEE NATION, the Cherokee Nation Environmental Programs is authorized to submit a formal application should the proposal be selected for said project and that Chad Smith, Principal Chief (or his designee) shall be authorized to conduct contract negotiations and execute all official documents in this regard.
