BE IT RESOLVED BY THE CHEROKEE NATION, that Nathan E. Barnard is hereby confirmed as a Member of the Administrative Appeals Board to fill a vacant seat beginning January 13, 2015 and ending October 31, 2015, as authorized by Legislative Act 12-96.
