WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation Economic Development Trust Authority Board of Directors was created and authorized by Legislative Act 36-89;

WHEREAS, the appointment of the Board of Directors in Legislative Act 36-89 was nullified by JAT 97-01;

WHEREAS, the appointment of members of the Board, replacing that portion of #36-89 previously addressing the appointment of said Board members, is provided for in Legislative Act 4-02;

WHEREAS, the term of office of Terri Daniels expired July 2009 and has been selected to be renominated by the Principal Chief;

WHEREAS, Terri Daniels is duly qualified to fill this vacancy pursuant to the laws of the Cherokee Nation.

BE IT RESOLVED BY THE CHEROKEE NATION, that Terri Daniels is hereby confirmed as a Board Member of the Cherokee Nation Economic Development Trust Authority Board of Directors for the term of two (2) years from July 2009 until July 2011.
