**WHEREAS**, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people; and,

**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government-to-government relationship with the United States of America; and,

**WHEREAS**, the Cherokee Nation has the following equipment utilized for ground-penetrating radar surveys in its inventory that has been deemed appropriate for continued use by the Cherokee Cemeteries Restoration Organization; and,


**WHEREAS**, the Cherokee Nation Warehouse desires to donate these item(s) in "as-is" condition; and,






