**WHEREAS**, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

Furniture- Desk CN # 0972 Cherry Wood Double PED DESKS


**WHEREAS**, the Cherokee Nation Information Warehouse desires to donate this equipment in “as- is” condition.




