WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government on behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;

WHEREAS, the Cherokee Nation is desirous of participation in the ICDBG grant program through submission of an application for Housing Rehabilitation for Fiscal Year 2015;

WHEREAS, HUD has set out requirements for citizen participation as a prerequisite to application;


WHEREAS, the Cherokee Nation is continuously seeking and responding to citizen questions and comments through ongoing processes of the Tribe in order to better serve its citizenry;

WHEREAS, the Cherokee Nation has met the specific requirements of HUD as set out through advertisement, toll free response numbers, public hearing, response to comments, and requests made by respondents;


