### APPROVAL OF MINUTES

### REPORTS:

1. Human Services Department - Norman Merriman

*Ms. Norma Merriman offered to answer any questions from her report. She stated the angel tree kick off will be November 24th at 4:00 p.m. They expect a large number of children for the angel tree from last year. They are using the day work program workers. Councilor Bill John Baker inquired about getting more funds to supplement the angel tree due to the large numbers of angels on the tree. Councilor Bill John Baker suggested adding more money to the budget. Councilor Cowan Watts stated the Speaker and the chair of Executive and Finance need to look at the existing budget before making a decision.*

*Councilor Bill John Baker inquired about helping a family to get some funding from the Self Help Program to help with their driveway. Councilor Bill John Baker made a motion to approve. Councilor Glory Jordan seconded the motion. Councilor Thornton stated the Roads Department has funding to help with driveways. Councilor Buzzard stated the funding doesn't cover tin horns. Mr. Soap stated they have so much money allocated. They have received so many requests and they have the 14 county area to cover. Chair Buzzard stated to pull the old Resolution and look how it reads.*

## 1. A RESOLUTION AUTHORIZING THE CHEROKEE NATION TO EXTEND THE SECTION 184 LOAN PROGRAM SERVICES TO CHEROKEE CITIZENS LIVING IN THE STATE OF TEXAS AND THE STATE OF ARKANSAS

**Sponsors:** Councilor Julia Coates

*Councilor Coates made a motion to approve. Councilor Jack Baker seconded the motion. Ms. Anna Knight provided some additional information about the 184 Program. There are 23 states that are eligible for the program. Councilor Glory Jordan voiced her concern regarding how it will impact the 14 county jurisdiction for the funding.*

**Councilor Glory Jordan made a motion to table. Councilor Snell seconded the motion. Motion failed with the following roll call vote:**

*Councilor Coates stated the state of Oklahoma is already overwhelming all of the other states by utilizing the funding money. Councilor Thornton inquired if Arkansas was included in the funding. Ms. Knight stated parts of the state were. Councilor Thornton inquired if there was enough funding for the whole state. Councilor Thornton offered a friendly amendment to add the whole state of Arkansas. Councilor Coates accepted the friendly amendment. Councilor Jack Baker seconded. Mr. Marvin Jones stated the can expand to all areas. They intend to cover Indian areas. The Indians in Oklahoma have a bigger benefit for the funding. They are working on the jurisdiction areas. The funding is based on the 14 county areas. It is subject to the NAHASDA funds and can be portioned out to other areas.*

**Motion to approved with admendments carried with Councilors Crittenden, Glory Jordan, and Snell opposed.**

- 2. A RESOLUTION APPROVING AND AUTHORIZING THE SUBMISSION OF THE FISCAL YEAR 2010 INDIAN HOUSING PLAN TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT

*Councilor Glory Jordan voiced her concern regarding the funding for the housing plan. Mr. Marvin Jones stated there is no funding available for the FY '08. The new funding will not be available until October 1, 2010. The housing plan will be able to get an Indian Housing Plan passed through HUD.*

**Councilor Cowan Watts made a motion to approve. Councilor Cobb seconded the motion. Motion carried.**
