Councilor Byrd commented on Outpost #1 and suggested they also look at the Cherokee Restaurant. Councilor Cowan Watts inquired if they are considering other casino locations.

Career Services/Employment - Diane Kelley

Ms. Kelley announced they are working closely with CNB and their HR department in regard to job fairs. She gave an update on the new website for Cherokee Career Connections. They will be holding construction fairs soon. They are working on submitting for three different grants. They continue to meet on a regular basis with the Macy's group. Councilor Lay inquired if they have an office in the Tulsa or Owasso area. Councilor Cowan Watts inquired when Macy's would be hiring.

Commerce - Anna Knight

Ms. Knight offered to answer questions from the report. Councilor Buzzard inquired about the process for commercial loans. Councilor Coates inquired about Section 184 loans in Texas. Chair Taylor inquired about the completion rate for the Financial Peace University. Councilor Glory Jordan requested an example of a micro loan process. Ms. Knight stated she would provide a report regarding the cattle loans.

Historical Society - Candessa Tehee

Dr. Candessa Tehee offered to answer questions from the report provided. She reported on the demolition of the ancient village. The Cherokee Homecoming Art Show will be held in August. Councilor Byrd commented on the need to get the drama up and going again. He inquired where the language, heritage and culture of our tribe have gone. Councilor Lay inquired if a round house discussion could be held and requested to be able to see the master plan. He also inquired about the preservation of artifacts. Ms. Susan Chapman Plumb commented she and Dr. Tehee is working on a long term plan that will provide financial security to the Heritage Center. She commented the current board structure is out dated, she gave an overview of some of the changes they are considering for the board.
