### CALL TO ORDER

**Speaker Frailey called the meeting to order at 6:00 p.m.**

### APPROVAL OF MINUTES OF PREVIOUS MEETINGS

**Councilor Cowan Watts made a motion to approve the April 13th regular session minutes. Councilor Bill John Baker seconded the motion. Motion carried.**

**Councilor Bill John Baker made a motion to amend the agenda to include items 19 and 20 in new business as a resolution for a grant application to the Department of Energy and a resolution in support of the area Boys and Girls Clubs. Councilor Cowan Watts seconded the motion. Motion carried.**

### STATE OF THE NATION

*Principal Chief Chad Smith requested a few moments to honor our fellow Cherokee citizens whom we have lost since the last Council meeting. Those honored were Betty Hummingbird, Chester Oosawhee, Gayle Perry, Mary Crawford, and Al Crutchfield. Veterans honored this month were T. Roosevelt Manning and Timothy W. Patrick. In program highlights the Strawberry Festival parade was held last Saturday where candy and beads were given out. CNE organized a volunteer painting of the Jay Clinic which was held earlier this month. The Health Services have readied their pandemic plan in case the Swine Flu reaches the area. The Community Service and Cultural Resources departments assisted in the annual picnics in Bakersfield and Sacramento, California. The Commerce Department held a ribbon cutting ceremony at the Courthouse Square for the official opening of the*

*Cherokee Hills Byway. Community Service worked with the Jay community on a baseball and softball park. The JOM Co-Partner program held their Cultural Competition Awards Banquet recently where they presented awards to more than 400 students throughout our jurisdiction. The Cherokee Nation Leadership Program organized an event that brought Heisman Trophy Winner and OU quarterback, Sam Bradford to Sequoyah Schools to speak about leadership. The tribe honored him that evening for his leadership both on and off of the field. Sequoyah was also visited by Olympic Gold Medalist Billy Neals where he told his inspiring story. The Sequoyah Seniors which will be acknowledged at the end of this week have many achievements. More than 9% of the graduating class will graduate with a Gates Millennium Scholarship. This is an all expense paid scholarship to the college of their choice for the next eight years. The Gates Scholarship recipients this year are Rikki Shook, Shayne Boyd, Corey Still, Kaleha Hooper, and Courtney Reeder. Another 15% of the graduating class will receive the Oklahoma Access Award for Higher Learning in the amount of \$2,000 for tuition to an Oklahoma University. Of this years graduating class 66% will be attending universities or colleges, 18% will attend Vocational schools including one who will attend a metropolitan film school in London England. Two seniors are entering the armed forces. Shayne Boyd has been accepted into the Air Force Academy. Senior Toffee Coachman received the greatest amount of scholarship from the University of Denver in the amount of \$226,000. Other notable scholarships received by our graduates include the Red Clay Scholarship from the Cherokee Nation, The Dell Scholarship, The National Indian Education Association Award, and 3 Patty Iron Cloud National Native American Initiative Scholarships. The Cherokee Nation Scholarship deadline is June 12th and is available for both graduate and under graduates. Applications are being accepted to several youth programs. Miss Cherokee Leadership is accepting applications at this time. The Cherokee National Treasurers Program is accepting nominations through the 31st of July. He announced Megan Williams's daughter of Cherokee Nation employee Tonia Williams is an eleventh grade student at Sequoyah and will be going to MIT this summer on a minority introduction to engineering and science summer program.*

##### Monthly Reports:

##### Housing Authority - David Southerland

*Gary Cooper announced Mr. Southerland is attending the National American Indian Housing Council. The Housing Authority Board meeting is scheduled for next Tuesday at 5:30. The agenda includes the FY2010 budgets and discussion of a 20 acre site adjoining the elderly housing in Stilwell. He announced they have stimulus funded projects that have been sent to purchasing.*

##### Cherokee Nation Enterprises - David Stewart

*Mr. Stewart announced the March income was just above last year. Operating expenses are up approximately 15%, the sales tax revenue is approximately the same and the dividend back to the tribe is approximately \$120,000. They opened*

*floors five through fifteen on the hotel tower in Catoosa along with the meeting and convention space. They continue the construction of phase II at West Siloam Springs. CNE's total employment is 3424 with approximately 70% Native American. He recognized employees for their charitable efforts. He introduced Molly Jarvis who gave a brief update on some of their community relations projects. Ms. Jarvis who is on the board for Big Brothers and Sisters announced they participated in a project for this group "Bowl for Kids Sake" where they raised \$15,000 for the organization. She introduced some of the team captains as Lisa Long, Jeremy Ketcher, Nina Perryman, Susie Whitekiller, Tiffany Reavis, and Emily Bushyhead. Councilor Fishinghawk gave appreciation for attending the Strawberry festival, purchasing the berries and donating back to the diabetes program. Councilor Crittenden gave appreciation for the sponsorship at the rodeo.*

Cherokee Nation Business, Inc - David Stewart

*Mr. Stewart the operating subsidiaries are all profitable and ahead of budget. They will be finalizing the acquisition company within the next 30 days. The landfill is scheduled to open in June.*

Cherokee Nation Industries - Bryan Collins

*Mr. Collins announced the consolidated financials have not been finalized for April therefore he would report those numbers at the Executive and Finance Committee. The local employment remains steady at 478 with 82% being Native American. CNI had approximately 40 employees participate in the Strawberry Festival. The Oklahoma State Regents for Higher Education selected twenty one business relationships and NSU and CNI was selected and honored for their relationship. The board meeting is scheduled for May 18th at the Tulsa office. Mr. Collins recognized one of the first employees to be hired at CNI in 1969 as Lizzie Duvall. He announced they will be celebrating CNI's 40 year anniversary on June 20th.*

*Councilor Cowan Watts announced as an attempt to increase voter registration and participation this legislation compels the tag agencies and the clinics to provide voter register forms.*

**Councilor Cowan Watts moved for the approval. Councilor Crittenden seconded the motion. Councilor Hoskin Jr. offered a friendly amendment to strike the wording "and offer" in Section 5 paragraph 2. Councilor Cowan Watts and Crittenden accepted. Motion carried by acclamation.**

3. **AN ACT AMENDING LEGISLATIVE ACT #19-08 AUTHORIZING THE COMPREHENSIVE BUDGET FOR FISCAL YEAR 2009 - MOD 7; AND DECLARING AN EMERGENCY**

*Councilor Jack D. Baker stated this budget mod increases the budget authority by \$4,286,000 and included is the tribal bridge program, the supplement youth employment program, health equipment replacement, and housing management.*

**Councilor Jack D. Baker moved for approval. Councilor Cowan Watts seconded the motion with a friendly amendment to use third party revenue carryover to retire debt on the 2006 bond obligations to repurchase \$500,000 of the 4.6% bonds at 85% of the original amount for a total of approximately \$425,000. Councilor Jack D. Baker accepted. Motion carried by acclamation.**

Red Clay Joint Council

*Speaker Frailey announced items 4 through 18 are Joint Council resolutions. Last month the 25th reunion of the Cherokee Nation and Eastern Band Joint Council was held at Red Clay, Tennessee. Red Clay was the last meeting place in 1837 before being driven from the homeland to Oklahoma in 1838. Over 4,000 people lost their lives over the emphasis trail. In 1984 the Cherokee Nation Council and the Eastern Band Cherokees met at Red Clay commemorating the 1837 Council meeting and honoring those who lost their lives in 1838. The Cherokee Nation and the Eastern Band had been separated for almost 150 years at this time. This year the*

*two tribes met again to resolve the items included in the fifteen resolutions presented here for approval tonight.*

*Councilor Jack D. Baker stated during the Joint Council meeting a quorum was lost of our Council of members present. Robert's Rules of Order states a point of order should be called if a quorum is lost however no one called point of order. He stated with no point of order being called the resolutions are probably legitimate but to avoid controversy they are being put forward tonight. All of these were passed unanimously by the eleven members present and the twelve member of the Eastern Band. Rules and procedures are being formulated for joint council meetings to cover items like this in the future.*
