**A RESOLUTION AUTHORIZING THE SUBMISSION OF A SPECIAL GRANT
APPLICATION TO THE NATIONAL PARK SERVICE TRIBAL HERITAGE GRANT
FOR HISTORIC PRESERVATION FUNDING**

WHEREAS, the Cherokee Nation since time immemorial has exercised the sovereign rights of self-government in behalf of the Cherokee people;

WHEREAS, the Cherokee Nation is a federally recognized Indian Nation with a historic and continual government to government relationship with the United States of America;


WHEREAS, the Cherokee Nation has a strong interest and commitment to the preservation of the Tribe's history, culture, traditions and tribal art and skills; and,

WHEREAS, National Park Service has funding available through Tribal Heritage Grants for Historic Preservation Funds to conduct a needs survey of the National Treasures; and, therefore,

BE IT RESOLVED BY THE CHEROKEE NATION, that the Council approves and authorizes the submission of a grant proposal the National Park Service Tribal Heritage Grant Historic Preservation Funding.


CERTIFICATION



Victoria Vazquez - Notes for Resolution to authorize a special grant, Historic Preservation Funding, February 27, 2014

- This grant is for a needs assessment to survey National Living Treasures to determine how mentors wish to participate in teaching/passing on our traditional arts.
- The hope is that a second grant will be awarded later in order to give stipends to teachers, incentives to students and fund a free artist co-op for marketing the art works.
- While serving as Tribal Councilor, Victoria Vazquez will receive no financial benefit/stipend from this grant.
- We hope to utilize our CN Education Department for oversight/administration of this program, pending agreement from Bill Andoe.
- We plan to receive recommendations from participating Living Treasures for potential students, and one National Living Treasure, Jane Osti, of Tahlequah has already begun mentoring a young woman in hand built pottery making and clay processing techniques with great results.
