CALL TO ORDER

Chair Hoskin Jr. called the meeting to order at 1:21 p.m.

INVOCATION

Councilor Snell gave the invocation.

APPROVAL OF MINUTES

Councilor Hargis moved to approve the March 28th regular session minutes. Councilor Lay seconded the motion. The motion carried.

AMEND THE AGENDA

Councilor Glory-Jordan moved to amend the agenda to bring #1 of old business and #1 and #2 of new business and also to take from the table the resolution authorizing the limited waiver of sovereign immunity in connection with the wind energy evaluation leases and wind resource leases to immediately following the approval of this motion. Councilor Fishinghawk seconded the motion. Councilor Lay requested division, Chair Hoskin Jr. requested two separate motions.

Councilor Glory-Jordan moved to amend the agenda to bring #1 of old business and #1 and #2 of new business be considered prior to the reports. Councilor Hargis seconded the motion. The motion carried.

wind energy evaluation leases and wind resource leases. Councilor Cowan Watts seconded the motion. Chair Hoskin Jr. gave clarification on the route in which this resolution has taken. Councilor Lay requested clarification and a few moments to review the document provided.

The motion carried with Councilor Lay opposed.

Councilor Byrd moved to approve. Councilor Walkingstick seconded the motion. Ms. George gave a brief overview of her background.

After several questions the motion to approve carried with no opposition.

1. 13-061 A RESOLUTION CONFIRMING THE REAPPOINTMENT OF STEVEN M. WILSON AS A COMMISSIONER OF THE CHEROKEE NATION TAX COMMISSION

Councilor Glory-Jordan moved to approve. Councilor Hargis seconded the motion.

After questions were asked the motion to approve carried with no opposition.

2. 13-062 A RESOLUTION CONFIRMING THE NOMINATION OF GLENDON KAY WATKINS
AS A BOARD MEMBER OF THE ECONOMIC DEVELOPMENT TRUST
AUTHORITY BOARD OF DIRECTORS

Councilor Glory-Jordan moved to approve with an amendment for the seat to reflect seat two (2) not seat four (4). Councilor Walkingstick seconded the motion.

Councilors Fishinghawk, Hargis and Lay requested to be added as sponsors.

After questions ceased the motion to approve as amended carried with no opposition.

OB4. 13-049

A RESOLUTION AUTHORIZING THE LIMITED WAIVER OF SOVEREIGN IMMUNITY OF THE CHEROKEE NATION IN CONNECTION WITH THE WIND ENERGY EVALUATION LEASES AND WIND RESOURCE LEASES TO CHILOCCO WIND FARM, LLC

Councilor Glory-Jordan moved to approve and provided a brief explanation of the request to bring off the table and reconsider today. Councilor Cowan Watts seconded the motion. Chair Hoskin Jr. directed attention to two emails provided today pertaining to the consultation fee being waived. Councilor Lay voiced concerns with the situation and requested an investigation be held explaining how the questions asked and information discussed in a FOIA request he submitted is included in the two emails provided today. Councilor Cowan Watts voiced concern for not being able to see the contracts. She questioned the multiple funding triggers. Assistant Attorney General, Elizabeth Odell provided some clarification. Councilor Cowan Watts inquired what contracts are going to take place over the life of the project. Chair Hoskin Jr. requested Ms. Odell commit in assisting in making sure the documents are available for review by this Council. Councilor Cowan Watts inquired if any money has been expended by the Cherokee Nation or our entities on this project to date. Councilor Keener questioned the involvement of CNB on the project. Councilor Frailey questioned what this phase triggers if approved. Councilor Lay once again voiced his multiple concerns with the project. Upon the completion of

other Councilor comments Chair Hoskin Jr. stated the expectations of the committee would be to be given the opportunity to inspect the documents at the Attorney General's office prior to the Council meeting.

Marshal Service - Shannon Buhl

Ms. Christina Carroll provided an update on codification by stating it is moving along well. She was unable to provide any timeline or specific deadlines. Councilor Cowan Watts inquired if there is a plan to keep the codification process current once this large task is complete.

Election Commission - Bill W. Horton

No one was present to report. Councilor Cowan Watts commented she is hearing concerns in the communities and requested a representative be present next month.

Tax Commission - Sharon Swepston

Ms. Swepston provided a handout of sample cards for the tax exemption for the veterans. She requested input from the Council so they can move forward. They look to have the policy finalized in the next 30 days.

Self-Governance - Vickie Hanvey

Mr. Clint Hastings reported in the absence of Ms. Hanvey. He offered to answer questions from the report provided. He announced Ms. Hanvey is representing the Eastern Oklahoma Region on the Tribal Interior Budget Council this week in Washington D.C.

Gaming Commission - Jamie Hummingbird

Ms. Rhonda Trumbla offered to answer questions in the absence of Mr. Hummingbird.

Registrar Citizenship Data Update - David Justice

Mr. Justice announced the Registration Department has implemented a new database and are currently in training. Chair Hoskin Jr. requested his concern for space issues within their department be voiced. Councilor Cowan Watts inquired about the new database and requested a report next month.
